

TENDER NOTICE FOR COLLEGE CANTEEN

- The application form is available on college website i.e. <https://govtcollegenurpur.in/> or can be had from the office of the Principal Govt. Arya Degree College, Nurpur with tender fees of Rs. **500/-** (Rupees Five hundred only) on all working days w.e.f. 15th July, 2023 onwards and the last date for receipt of duly filled application is 25th July, 2023 upto 11:00 am in the office of the Principal and the tender will be opened on the same date i.e. 25th July, 2023 at 2:00 pm.
- The application form must be accompanied with a banker draft for Rs. **20000/-** (Rupee twenty thousand) only drawn in favour of **Principal Govt. Arya Degree College Nurpur Himachal Pradesh** for the deposit of earnest money/security (Refundable).
- Application not accompanied with earnest money/security of Rs. **20000/-** (Rupees twenty thousand) only will be rejected and his/her application will not be considered for award of tender.
- Minimum reserve price for bid is Rs. **42000/-** (Rupee forty two thousand) only for the period of 12 months from the date of allotment.
- Application duly filled under sealed cover must reach the office of undersigned upto **25th July, 2023** and superscripted as "**TENDER FOR COLLEGE CANTEEN 2023-24**" up to **11.00 am** and will be opened on same day at **02.00 PM** in the office of undersigned.


Terms and Conditions:

1. The Allottee to whom the canteen will be allotted shall have to deposit the **40%** bid price immediately within 3 days and rest in three equal installments detailed as:-
First installment on 10th October 2023, 2nd on 10th February 2024, 3rd on 10th July 2024.
2. The electricity charges have to be paid by the canteen holder and its every month payment proof must be submitted in the college office before 10th of every month.
3. Every month canteen facility will be reviewed and if the canteen committee does not find it up to the mark, the contract will be rescind without assigning any reason and amount deposited will be forfeited (on the recommendation of the college canteen committee). Allottee shall have to supply all the articles throughout the year even in lean season.
4. Canteen allottee shall have to take care of all the articles i.e. tables, chairs, ceiling fans, staff cabin etc. provided to him/them.

5. Canteen allottee shall be responsible for cleaning of canteen and its surroundings.
6. He/ She may work between 8.30 AM. to 6.30 PM. in summers and till 5.30 PM. in winters and nobody is allowed to stay in the canteen during night. If needed, during special occasions, the prior permission/approval from the college administration to be sought.
7. Canteen Allottee shall have to maintain the quality of the food articles that can be inspected at any time.
8. Canteen Allottee should not have been barred by any court to contract.
9. The contract for the college canteen will be valid for the period of one year starting from the day of allotment.
10. Smoking is strictly prohibited in the college canteen. Besides this the allottee shall have to see that there is no drug abuse in the canteen. Incident of ragging if any should be brought to the notice of the Principal, Govt. Arya Degree College Nurpur immediately.
11. On allotment he/she shall have to start giving services within a week.
12. The vendor can be asked to provide canteen services at entire premises of the college.
13. If allottee will withdraw to run the canteen after allotment he/she will be charged with additional 25% of bid amount and the next highest bidder shall be asked by the undersigned for the allotment of college canteen. None of any bidder have any right of objection for such allotment.
14. Any food items/Plastic banned items which have been restricted/banned/unauthorized as per order of state Govt./Centre Govt./Hon'ble Courts shall strictly be prohibited to sell in the canteen for students.
15. The rate list of food articles (approved by the college administration), must be displayed by the allottee in and outside the canteen for information to the college students. The allottee can not charge the price in excess of approved rates. If the college administration receives any complaint regarding this, a special penalty upto **Rs. 3000/- (Rupees three thousand)** only.
16. Keeping in view the health of students if any food article of expiry date is found by the college administration/students, then a special fine of **Rs. 5000/- (Rupees five thousand)** only shall be imposed to the allottee.
17. The allottee shall not allow the entry of outsiders in the canteen. Failing which a penalty of Rs. 10000/- (Rupees ten thousand) only shall be imposed.

18. Principal Govt. Arya Degree College Nurpur reserves the right of **rejecting** or **discontinuing** the contract without assigning any reason for breach of any of the provisions of the contract.

In case of allotment, the canteen allottee will execute an agreement duly attested by competent authority (Notary) for the acceptance of all terms and conditions mentioned above.
